Application to Serve Monterey County Civil Grand Jury

COMMITMENT

Service on the Civil Grand Jury is a voluntary commitment. The Civil Grand Jury forms committees and sets its own schedule for interviews, investigations and meetings. Persons selected for service should plan to commit to a minimum of 15-20 hours per week for a period of one year (January-December). However, based on each individual's availability, it is not uncommon for some members to work in excess of this estimated time.

Citizens of Monterey County who are interested, qualified, and able to commit a portion of their time each week for a year are encouraged to submit this [Application to Serve](#) to be considered for nomination to the Civil Grand Jury.

REWARDS

Rewards for Civil Grand Jury service come from increased knowledge of local government and the satisfaction of making a worthwhile contribution to the improvement of government operations.

RESOURCES

Civil Grand Jurors are provided the following resources:

- ❖ A free two-day Civil Grand Juror training workshop conducted by professional trainers and former members of grand juries throughout the State from the California Grand Jurors Association (www.cgja.org);
- ❖ Availability of Civil Grand Jury legal advisors – County Counsel, Advisor Judge and District Attorney;
- ❖ Use of a dedicated office and conference space provided by the County of Monterey;
- ❖ Reference materials, internet access, computer, fax, phone and office supplies;
- ❖ Part-time administrative support from the jury liaison.

COMPENSATION

Members are paid \$15 per day for attendance at Civil Grand Jury meetings. In addition, roundtrip mileage to attend regular grand jury meetings is paid at the current Federal mileage rate.

QUALIFICATIONS

To qualify to serve on the Civil Grand Jury, you must meet the following requirements as outlined in Penal Code §893:

- ❖ Be a citizen of the United States; 18 years of age or older
- ❖ A current resident of Monterey County and for one year immediately before being selected;
- ❖ Possess natural faculties of ordinary intelligence, of sound judgment, and of fair character;
- ❖ Possess sufficient knowledge of the English language.

DISQUALIFICATION

A person is not legally qualified to apply or serve on the Civil Grand Jury if any of following apply:

- ❖ The person is serving as a trial juror in any California court;
- ❖ The person is serving as an elected public officer;
- ❖ The person has been discharged as a grand juror in any California court within one year;
- ❖ The person has been convicted of malfeasance in office or any felony or other high crime;
