

## WHAT IS 11395 H&S Treatment Court?

The 11395 H&S Treatment Court is a structured, court-supervised program designed to provide treatment and support for individuals facing charges related to controlled substances. This alternative sentencing approach focuses on rehabilitation rather than incarceration, offering participants the opportunity to address substance use issues through treatment, counseling, and case management.

Participants who successfully complete the program are eligible for the dismissal of their drug-related charge(s).

### Graduation

**Upon successful completion of the 11395 H&S Treatment, your referred drug-related charge(s) will be dismissed.**

## SUCCESS...How can I achieve it?

Your commitment to the 11395 H&S Treatment Court, includes:

- Regular contact with your support team.
- Regular Court appearances to receive encouragement from the Court and to report on your program progress.
- Treatment, which will be individualized to meet your specific needs and may include outpatient care or residential treatment, or a combination of both.
- Drug and alcohol testing and/or electronic monitoring of alcohol use.
- Attend self-help/recovery meetings such as AA, NA, or similar non-denominational programs.
- Your team will provide comprehensive support that may include: Aftercare counseling, referral to vocational training, education and/or job placement services, and other treatment/referrals as individually necessary.



## MONTEREY COUNTY

### *11395 H&S TREATMENT COURT*

*The 11395 H&S Treatment Court is a voluntary program designed to support eligible justice-involved persons ready to confront their substance use issues and commit to treatment in an effort to resolve their court case(s).*

## PROCESS

Participation in the program requires the entry of a plea of guilty/no contest to a violation of 11395 H&S. The program consists of four phases and requires a minimum commitment of 18 months to successfully complete. Each phase has specific requirements aimed at promoting accountability, stability, and long-term recovery. Participants must comply with all court orders, demonstrate consistent progress, and complete all phases to graduate from the program.

*The 11395 H&S Treatment program can be challenging, but with commitment, effort and honesty, you will find the Treatment Court program is designed to give you the support and tools necessary to build a fulfilling and rewarding life.*
